Redistricting Objective:

The objective for the smallest county in Texas, Rockwall County is to not get absorbed into Dallas or Collin Counties.

Hearings Summary:

In order to gather information that will aid the Texas Legislature in making redistricting decisions, legislative committees generally hold public hearings in the months leading up to the redistricting session. While the official census population data is not available until after the session begins, the hearings provide an opportunity for citizens to present relevant testimony concerning local preferences, communities of interest, local voting patterns, and other issues that the legislature may consider when redrawing district

lines. The hearings also promote public awareness of the legislative redistricting process.

Timeline:

The time for participation from the community on Redistricting efforts is critical. We must act quickly if we want our voices heard in Rockwall County. Due to weather conditions, the Feb. 27th has been rescheduled. Interested parties may register for testimony.

Texas Legislation—Launch of First Annual Sanctity of Life

Texas continues to promote life-affirming legislation, making it one of the most protective states in the nation. But because of this, we remain a prominent target of abortion activists. Texas also recognizes the humanity of unborn babies and provide funding for adult stem-cell research projects. Our state does not prohibit fetal experimentation.

Texas is ranked #20 in the U.S. on sanctity of life issues which means we still have a lot of work to do.

According to "Defending Life 2021" Americans United for Life on Texas current legislation on sanctity of life issues: Here are some of what is being done in Texas

ABORTION

- Texas possesses an enforceable prohibition should the U.S. Constitution be amended or certain U.S. Supreme Court decisions be reversed.
- Texas limits abortion at 5 mo. based on medical evidence that an unborn child at that stage of development can feel pain.
- A third-trimester abortion may not be performed on a viable fetus unless necessary to preserve the women's life or prevent a "substantial risk of serious impairment" to her physical or mental health or when fetus has a severe and irreversible abnormality. An additional law provides that a third-trimester abortion may not be preformed on a viable fetus unless nec-

essary to prevent "severe, irreversible brain damage" to the woman, paralysis, or if the fetus has a severe and irreversible "brain impairment."

- Texas prohibits partial-birth abortion. Ongoing litigation.
- Texas prohibits the dismemberment abortion procedure. The law is enjoined and in ongoing litigation.
- A physician may not perform an abortion on a woman until at least 24 hours after obtaining her informed consent and after informing her of the nature and risks of the proposed abortion procedure, including the gestational development of the unborn child and available assistance from both public and private agencies.
- Texas requires the performance of an ultrasound before an abortion.
- A physician may not perform an abortion on a minor under the age of 18 without the written, notarized consent of one parent unless there is a medical emergency of the minor obtains a court order. Texas has created a resumption that an abortion patient is a minor unless valid government ID is shown.
- A Texas law requiring that abortion facilities meet the same health and safety standards as other facilities performing outpatient surgeries was struck down by the U.S. Supreme Court.
- Texas requires that physicians providing "medical abortions" be able to accurately date a pregnancy, de-

termine the pregnancy is not ectopic

• The Texas Supreme Court has upheld a law limiting taxpayer assistance for abortion to cases where the abortion is necessary to preserve a woman's life or when the pregnancy is the result of rape or incest.¹
