# Border Security — U.S. Congressman Pat Fallon

Biden's border crisis has reached a breaking point, we are able to see the effects of two years of not treating our borders as the primary defense of this country's national security. This past month broke the CBP's 22-year record high for illegal border crossings with 239,416 crossings. His radical policies are actively making our communities more dangerous!

Since Biden has taken office, an estimated 700,000 illegal immigrants have been tagged as "getaways." That means there are almost 1 million unidentified, illegal immigrants running freely in our country. In what world is this acceptable?!

What makes matters worse, is that the state of Texas is having to bear the brunt of this crisis. I recently introduced legislation that would help ease that Burden on Texas. My bill, the Lone Star Reimbursement Act, would require the Department of Defense to reimburse the State of Texas for the costs of Operation Lone Star incurred in fiscal years 2021 and 2022.

As a border state, Texas is disproportionally impacted by illegal immigration, but we shouldn't be forced to bear the entire finan-



cial burden when it comes to securing the entire country. I look forward to continuing to work with my colleagues to secure our southern border and protect our communities.

### Terry D. Garrett, Sheriff Rockwall County, Texas

Terry Garrett began his Public Safety career in 1976, while a student at Rockwall High School, working as an ambulance attendant. He joined the Rockwall Volunteer Fire department in 1978 while continuing to work as a medic for American Air/Land Ambulance and dispatcher for Rockwall PD.

#### Rockwall PD, retired (26 years)

\* 1979 – Attended North Texas Regional Police Academy as a patrol officer for Rockwall Police.

- \* 1985 Initiated the department's Crime Prevention Program, School Resource Program, conducted juvenile investigations and public information tasks.
- \* 1990 Promoted to Sergeant in charge of Training, Community Services, School Resource, Public Information, Special Operations, and Emergency Management.

\* 2000 – Promoted to Uniformed Operations Lieutenant over Patrol, Special Operations, Community Services, Training, Public Information, School Resource.



\* 2004 - Transferred to Support Services Lieutenant in charge of Criminal Investigations, Records, Evidence, Training, and Community Services. (cont'd Pg 3)

## **Sherriff Eavenson**

Retired Sheriff Harold Eavenson began his law enforcement career with the Texas Department of Public Safety in April 1961, as recruit trainee. He was assigned to the Highway Patrol Service in August 1961, promoted to Agent in the Criminal Intelligence Service October 1969 and to Sergeant in the Criminal Intelligence Service August 1974. He was assigned to an Organized Crime Unit for three years. He is a graduate of the FBI National Academy 112th Session in 1978 and has a BA in Psychology from the University of Texas at Dallas. He accepted the position as Director of Security of First National Bank in

in Dallas, April 1979. At that time, First National was the largest bank south of Chicago. He served sixteen years in the private sector.

In February 1995, he formed his own consulting firm, Harold Eavenson & Associates, specializing in bank security training. In late 1999, he was asked by numerous citizens of Rockwall County to run for Sheriff and won in a runoff election in April 2000, taking office on January 1, 2001.

Mr. Eavenson retired December 31, 2020, as the second longest serving Sheriff in Rockwall County history. Among his

accomplishments as sheriff, he initiated a public corruption investigation on the twenty-two year District Attorney. The investigation spanned seventeen months and involved two different Special Prosecutors, an FBI Agent, a Texas Ranger and Rockwall County Sheriff's Office, two different grand juries and two separate



trials, both of which resulted in convictions. He has a passion for Border Security and Asset Forfeiture. (cont'd Pg 3)

#### Urbino "Benny" Martinez Sheriff Brooks Co. Texas/ Mark Daniels Sheriff Cochise Co. Arizona

Brooks County, Texas Sheriff Urbino "Benny" Martinez has served Brooks County since 2009. Martinez plans, organizes, implements, administers, and evaluates all Sheriff's Office operations and programs. Sheriff Martinez studied at Baylor University.

Prior to Brooks County Sheriff's Office, Sheriff Martinez served as a Texas State Trooper from 1979 until his retirement in 2009, retiring at the rank of Sergeant. During that time, Martinez's responsibilities spanned from enforcing traffic and criminal laws, investigation of motor vehicle traffic collisions, and providing a visible police presence in his area of responsibility. In 1990, Martinez joined the Narcotics Service of the Department of Public Safety which charged him with the overall direction of the state's enforcement efforts against illegal drug trafficking in Texas. He played an integral role in identifying and targeting individuals and organizations diverting large quantities of controlled substances for illicit sale while undercover in the South Texas area until

his retirement in 2008. Sheriff Martinez' most current focus and attention has been drawn to the abundant illegal migration of persons from all over the world across the border of Mexico into the United States.

#### **Bisbee, Cochise County, Arizona**

Since November 2012, Sheriff Mark Daniels has been elected by the good citizens of Cochise County to serve as their 26th Cochise County Sheriff. "I continue to be Humbled, Honored and Dedicated to my oath of office for this incredible opportunity to serve you all with my personal commitment to sustain your Quality of Life as you would expect and your Freedoms and Liberties as scribed in the United States and Arizona Constitutions."

Sheriff Daniels is a 38-year veteran of law enforcement. He holds a master's degree in Criminal Justice Management from Aspen University and is a Certified Public Manager from Arizona State University. He has over 3000 hours of law enforcement training in his portfolio. He

attended Disney's Leadership and Executive Training programs and is a graduate of the Rural Executive Management.

He began his law enforcement career in 1984 after serving a successful tour in the United States Army. He progressed through the ranks with the Cochise County Sheriff's Office to the position of Deputy Commander after working numerous specialty assignments and leadership roles to include an appointment by the Arizona Governor for his dedicated efforts directed toward highway and community safety. Sheriff Daniels is a long time member of the Fraternal Order of Police, past member of the U.S. Depart. of Homeland Security Advisory Council, current member of the Arizona Peace Officer Standards and Training Board.

# **U.S. Supreme Court Overturns Roe V. Wade — Betsy Gallagher**

Supreme Court of the United States of America overturned Roe v Wade. This action has righted a massive overreach of government and given the decision on abortion back to each state government to decide individually.

On the morning of June 24, 2022, the ing from Senator Bob Hall. The Supreme Court action has paved the way for the State of Texas to initiate the "trigger law". "The Republican-led legislature passed HB 1280, dubbed the "Human Life Protection Act" in 2021. The law prohibits abortions except under limited circumstances, such as a life-threatening condition to the mother caused by the pregnancy"-(Senator Bob Hall) This law will go into effect 30 days after the Supreme Court issued a judgement.

> "The Court will issue its judgment only after the window for the litigants to file motion for rehearing closed," Paxton said in an official advisory. "A judgment can issue in about a month, or longer if the Court considers a motion for rehearing." This is just a first battle of many more to come for the unborn.

Our club (RCRHC) will continue to host fundraising efforts to support women who find themselves in unplanned pregnancies. We recognize that some women may find themselves in need of the love and support they require to bring a newborn into the world.
